

## ASCEPT Bellberry New Investigator Award

Details of award	The Bellberry New Investigator Award recognises and highlights the research contributions of New Investigators to the disciplines of Clinical and Experimental Pharmacology and Toxicology and provides a forum through which these contributions can be widely disseminated to ASCEPT members.						
Eligibility criteria	<ul style="list-style-type: none"> <li>• Financial member of ASCEPT.</li> <li>• Nominees for the Award must have been ASCEPT members for at least the previous 2 years, or if a valid interruption to membership exists, have been a member of ASCEPT for at least 2 years prior to the suspension of membership.</li> <li>• Nominees would normally be expected to have completed not less than two years and not more than eight years in employment since obtaining their highest tertiary qualification, allowing for career disruptions. There is no age limit.</li> <li>• Nominees for this award are required to be nominated by one current ASCEPT member. The Nominator must submit the application.</li> <li>• Past winners are not eligible to re-apply.</li> </ul>						
Application	<p>Applications must be submitted by the nominator to the ASCEPT Executive Officer via email at <a href="mailto:ascept@ascept.org">ascept@ascept.org</a> by the deadline.</p> <p>The application should include:</p> <ul style="list-style-type: none"> <li>• Letter of support from the nominator.</li> <li>• The nominee’s CV (maximum two A4 pages).</li> <li>• A statement of relative to opportunity, if relevant.</li> </ul>						
Selection process	<p>Applications will be assessed by an ASCEPT Board-appointed judging panel chaired by the President or a delegated member of the ASCEPT Board and will include a representative from Bellberry. The judging panel will be assembled in accordance with the ASCEPT Equity, Diversity and Inclusion Policy and any real or perceived conflicts of interests will be declared and recorded. Award	<p>The selected nominees will be presented with a certificate recognising their Award at the Annual Scientific Meeting. They will also be offered complimentary registration, return economy airfare (best possible price) and one night's accommodation to attend the meeting.</p> <p>Each awardee will deliver a 30 minute presentation at the ASCEPT Annual Scientific Meeting. The nominees are eligible for the BPS/ASCEPT Outstanding Young Investigator prize.</p>
