<p>Details of award</p>	<p>ASCEPT Fellowship is the highest honour that the ASCEPT Board may bestow upon current financial members of ASCEPT.</p> <p>Fellows are entitled to:</p> <ul style="list-style-type: none"> <li>• use FASCEPT after their name</li> <li>• recognition of attendance at welcome speech for all official ASCEPT events</li> <li>• receive both a plaque and lapel pin</li> <li>• early bird registration fee for the Annual Scientific Meeting</li> <li>• discounted registration rate for Special Interest Group Workshops held throughout Australia</li> <li>• receive the members-only Newsletter</li> <li>• discounted subscription to the Australian Medicines Handbook</li> </ul> <p>All fellows become life fellows on retirement and are listed on the ASCEPT website.</p>
<p>Eligibility criteria</p>	<p>A Fellow Member is an Ordinary Member, Life Member or Retired Member who:</p> <ol style="list-style-type: none"> <li>i. has been a Member for more than five (5) consecutive years; and</li> <li>ii. does not owe the Society any money; and</li> <li>iii. has made a significant contribution to the Society or has provided distinguished service to the Society; and</li> <li>iv. has provided distinguished service to the advancement of pharmacology and toxicology research and/or translation impact and/or education and/or advocacy and engagement</li> </ol> <p>The candidate must be nominated for Fellow Membership by:</p> <ol style="list-style-type: none"> <li>a. two (2) Fellow Members; or</li> <li>b. the President; or</li> <li>c. Immediate Past President;</li> </ol> <p>by submission of the nomination to the Board in writing (where the nomination has been accepted by the nominee); and</p> <ol style="list-style-type: none"> <li>v. is recommended for Fellow Membership by a majority of the Fellow Membership Committee who vote on whether to recommend approving the application; and</li> <li>vi. is approved for Fellow Membership by a majority of the Board who vote on whether to approve or reject the nomination.</li> </ol> <p>Nominations are independent and are not to be made by individuals themselves.</p>
<p>Application</p>	<p>Applications must be submitted to the ASCEPT Executive Officer via email at <a href="mailto:ascept@ascept.org">ascept@ascept.org</a> by the deadline.</p>

Selection process	<p>All nominations will be reviewed by the Fellow Membership Committee.</p> <p>The composition of the Fellow Membership Committee will be: the President, and either the President Elect or the Immediate Past President (whoever is on the Board at the time), and three Fellow Members of ASCEPT.</p> <p>It is noted that the ASCEPT Equity, Diversity and Inclusion Policy will be taken into consideration when establishing all selection panels.</p> <p>The ASCEPT Fellow Membership Committee receives and reviews nominations. The Fellow Membership Committee will decide Fellowship awards. The decisions taken by the Fellow Membership Committee are final.</p>
Award	<p>An official notification letter from the President will be sent to the successful candidates to invite them to attend the Annual Scientific Meeting for presentation of the Fellowship at the opening plenary.</p>
